Aims:

- 1. To test the ship's electrical systems.
- 2. To carry out tin tow net trials in order to test the performance of the cable winch.

Narrative:

R.V. CORELLA sailed at 1700 hours, 28 November and proceeded to a position 13 miles due east of Corton Roads to carry out tin tow net trials with the cable winch. Prior to sailing and during the cruise Laurence Scott & Electromotors and Belling and Lee carried out their work on the Motor Alternator and the final check of noise suppression throughout the ship. The results of the electrical work is the subject of a separate report circulated to those concerned.

Trials with the cable winch showed that the tin tow net could be handled satisfactorily by this winch. The warp meter in the cable winch console could not be tested, however, because when the asdic head was fitted in the bridge console the electric supplies to the warp meters in the main winch console and cable winch console had been left disconnected.

The staff were landed at Gorleston by pilot boat at 0930 hours, 29 November.
